The Between Two Homes®: Children in the Middle Class exceeds the guidelines for coparenting education in the state of Texas.

Texas Family Code, § 105.009. PARENT EDUCATION AND FAMILY STABILIZATION COURSE

The course must be instructed by a mental health professional who has at least a master's degree with a background in family therapy or parent education and include information on the following issues:

- (1) the emotional effects of divorce on parents;
- (2) the emotional and behavioral reactions to divorce by young children and adolescents;
- (3) parenting issues relating to the concerns and needs of children at different development stages;
- (4) stress indicators in young children and adolescents;
- (5) conflict management;
- (6) family stabilization through development of a co-parenting relationship;
- (7) the financial responsibilities of parenting;
- (8) family violence, spousal abuse, and child abuse and neglect; and
- (9) the availability of community services and resources.

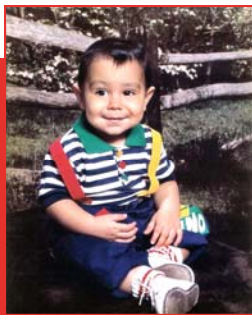
The Between Two Homes®: Children in the Middle Class consists of two parts that may be taken in either order, though we encourage you to attend Part I first.

- Alternative Dispute Options

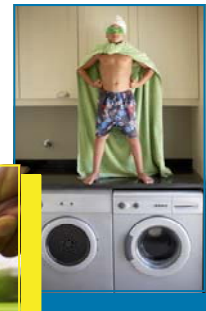


## PART II: THE CHILDREN

## Frequently Asked Questions

### WHEN ARE THE CLASSES AND HOW DO I PAY?

### WHAT ARE THE FEES?

\$40.00 per person, per part.

### WILL MY MONEY BE REFUNDED IF I ARRIVE LATE OR NO SHOW?
